Background to PWR Toronto Sikh Planning Process

The Sikh Council for Interfaith Relations (SCIR) coordinated the Sikh participation and presentations at the 2015 Salt Lake City Parliament of the World's Religions at which about 300 Sikhs attended from across the world.

In view of the Nov 2018 Toronto Parliament of the World's Religions (PWR), a Parliament Sikh Task Force was established by SCIR in early February 2017. The task force has been meeting since then about every other week to plan the Sikh participation under the leadership of Dr. Satpal Singh of Buffalo, NY as Convener and Dr. Tarunjit Singh Butalia (PWR Trustee) as Secretary.

The charge of the task force is **to coordinate and implement the active participation of the worldwide Sikh community at the upcoming parliament through:**

- 1) Significant international Sikh presence and engagement,**
- 2) Presentations at plenary and parallel sessions focused on interfaith and intrafaith issues, and**
- 3) Guru ka Langar, if possible, at the parliament to be led by the local Sikh community.**

Executive Summary

Over 500 Sikhs from across the world are expected to attend the Parliament in Toronto. About 50 Sikhs speakers will be presenting at the Parliament.

Plenary speakers include:

- **Gobinder Singh Randhawa**, Chairman of Ontario Sikh and Gurdwara Council, will address the Opening Ceremony on Nov 1 evening
- **Simran Jeet Singh** of Sikh Coalition will speak at the Opening Plenary session on Nov 1 evening
- **Tarunjit Singh Butalia** of Sikh Council for Interfaith Relations will be the Emcee for the Nov 2 evening plenary at which **Valarie Kaur**, interfaith activist, will speak (by video link)
- **Valarie Kaur** will address ((by video link) the Women’s Assembly on the morning of Nov 3 and **Tripat Kaur** as well as **Mahnaam Kaur** will participate in the opening procession
- **Keertani Jatha of Sikh Youth Alliance of North America** will participate in the Sacred Music Concert to be held Nov 4 evening and share a Sabad through Keertan by young adults
- **Valarie Kaur** will address (by video link) the Justice Assembly on morning of Nov 5
- **Kanwaljit Kaur**, OBE, President of Global Sikh Council, is coming from UK as an invited guest of the Parliament to address the Closing Plenary on Nov 7 morning

North American Sikh Experience: Lessons from History (Nov 4, 6pm to 7pm) - A four-member panel will discuss the Sikh journey from Punjab, India to Canada and United States. The panel monitor will provide a background of significant events that the community endured in both countries, including the Komagata Maru incident. Comparisons will be drawn between how journeys between the two countries varied, the familial approach to migration, detailed accounts of labor relations issue, and different community responses. Panelist will outline how democratic and legal frameworks of the United States and Canada enabled the Sikh community to challenge unaccommodating frameworks.

Persecution of Religious Minorities (Nov 6, 12:15pm to 1:45pm) - Persecution of minorities is a worldwide issue that needs to be addressed at international forums so that minorities all over the world can be helped and protected. Initially persecution explicitly referred to oppression due to one's religious practices and faith, it now encompasses race, ethnicity, gender and sexual orientation as well as religion. Persecution can be a two pronged attack from the governments through their actions, laws and policies, as well as hostile acts from private individuals, organizations and social groups with the concurrence or toleration of state actors. Presentations of speakers from Rohingya Muslim, Dalit, Sikh, Baha'i, Hindu, Chinese and Indian Muslim will highlight the problems from their individual experiences and explore avenues for assisting oppressed minorities and explore the role of interfaith engagement in this work.

Pluralistic learnings from the explorations of the Sikh Legacy remnants across Pakistan

In 1947, the region where Sikhism evolved was politically partitioned into two countries, India and Pakistan. As the dispersed Sikh community evolved in new lands around the world, the geopolitical situation deprived them access to their ancestral lands. Role of Religious Leaders in Alleviating Violence Against Women

Over one-third of women in the world (more than a billion women) suffer from physical and sexual abuse in their life. Violence against women is so woven into the fabric of our society that even highly egregious and brutal cases register only momentarily on our consciousness radar before disappearing forever. An important root cause underlying violence against women is a pernicious premise that God has created women as inferior to men. Many men, and women, even believe that women have been created to fulfill men's needs – both routine and vile. We must shed such warped notions that women are created as subservient to men, for the same Divine Light dwells in women as in men. We must stop accusing our infinitely compassionate and all-loving God of misogyny, and of being a co-conspirator with men for them to brutalize women under the ruse of it being God's Will. The leaders of faith have a responsibility, and a critical role to play, in ending the current nightmare for humanity, and in redeeming God.

Compassion as a Fundamental Ethical Imperative

One of the fundamental values underlying nearly every religion is compassion and love for fellow human beings. Taking On Our Own: The Inter-faith Inter-caste Coalition for Inclusive California Textbooks

When California wanted to revise its textbook curriculum, South Asian scholars came up with a balanced and inclusive set of improvements—but religiously oriented lobby groups attacked the academics, launching a campaign to frame all South Asian history through an Indian Hindu upper-caste nationalist narrative that erased the stories of Sikhs, Dalits, Buddhists, Muslims, women, and other South Asian nations. Langar* is the Sikh word for “open kitchen.” It was started by the first Sikh Guru, Siri Guru Nanak Sahib, and represents the principle of equality among all people regardless of religion, caste, color, creed, age, gender or social status. In addition to the ideals of equality, the tradition of Langar expresses the ethics of sharing, community, inclusiveness and oneness of all humankind.

Regardless of who provides the funds for the food and its distribution, it is called “Guru Ka Langar” and not of any person or persons. The Langar institution represents “sharing” and not “charity” and is to be simple meal and not a feast.

Upon entering the Langar Hall, you will be removing your shoes and scarves will be provided so you can cover your head before sitting cross-legged on the floor for the meal. For those who are unable to sit on the floor due to health reasons, a few tables and chairs will be provided. All those who come to share the Langar are treated as equal. To emphasize this, everyone has the same type of seating and the same choice of food that is served. Only vegetarian food will be offered daily to ensure that all people, regardless of their dietary restrictions, can eat as equals and no one goes hungry.

The Langar at the 2018 Parliament is being organized by the *Ontario Sikh and Gurdwara Council* in collaboration with the Canadian and international Sikh community.

Sikhs and Canada Timeline Exhibit by Sikh Heritage Museum of Canada

Through research by the Sikh Heritage Museum of Canada, this ground breaking timeline exhibit with original artifacts features new facts about the link between Canada and Sikhs dating all the way back to 1809 when the Governor General of the Province of Canada from 1843-1845, Charles Metcalfe (1st Baron Metcalfe) was serving as a Civil Servant for the British East India Company. In 1808 he was selected by Lord Minto for the responsible post of envoy to the court of Ranjit Singh at Lahore; here, on 25 April 1809, he concluded the important treaty securing the independence of the Sikh states between the Sutlej and the Jamuna. Sikhs have had a long history with and in Canada. From being residents for over 125 years since 1888, to having the first Prime Minister of Canada, Sir John A. Macdonald just after the BNA act, calling for an “army of Sikhs” in 1867. The first wave of Sikh settlers arrived in Canada in the early 1900’s. By 1908, the first Sikh Gurdwara (Place of Worship) was established in Vancouver. The Komagata Maru incident of 1914 still remains a very important historical anecdote in Canadian history as this was the first time Canada turned away migrants. Sikh pioneers played an important role in Canada’s nation building, from working in the lumber mills, to logging, forestry and farming, they toiled the vast land of Canada. Sikh pioneers also worked on the railway and although not given equal rights as Canadian citizens, they also served for Canada in WWI. Sikhs arrived in Ontario around 1911 and Dr. Sundar Singh spoke at the Empire Club of Canada. Sikhs secured their Canadian right to vote and full citizenship in 1947. Today, Sikhs in Canada are leaders in many fields & professions including education, law, social justice, banking, medicine, athletics, arts, entertainment, military and policing. Sikhs have been active in the political life of Canada, from being City Councillors, MLAs & MPPs, MPs, Premier and Ministers of State. Recently in 2014, Canada commemorated the Legacy of the Komagata Maru through Canada post in issuing a stamp.


